LIABILITY STATEMENT

The following is set forth and approved by the Board of Directors of the California Wheel Burners action revolver club in order that each member and/or competitor be appraised of the risks involved in this sport and the safety responsibility he/she assumes. We are pleased and proud of the safety record of our club since its inception. To maintain this record of safety, we must not relax our perception of the potential danger involved, nor our strict adherence to the safety rules as set forth by the NRA .

The match official(s) cannot be everywhere all the time, nor can they be expected to see everything from every position they may be in. Therefore, we must rely on all our members and competitors to assist us in the observation of safety rules.

As a condition of shooting in a Wheel Burners sponsored event or using the Wheel Burners range facilities at the Wes Thompson Piru Range, each member and/or competitor must familiarize him/herself with the potentially dangerous situations and to assume personal responsibility to observe the rules governing these situations. This responsibility also includes the necessity to prevent these situations from occurring by ensuring the observance of safety procedures by others and assisting with the enforcement of safety rules in a helpful and courteous manner.

The Board of Directors hereby authorizes each and every member and/or competitor to demand safety compliance from all other members and competitors. Refusal to comply with safety rules and procedures will make the offender subject to dismissal from the Club with loss of attendant privileges.

To assist our members and competitors, we have listed some of the potentially dangerous situations. Creating or encouraging any of these situations will be deemed failure to comply with safety rules and procedures. **MAKE NO MISTAKE; THIS SPORT HAS THE POTENTIAL OF BEING LIFE ENDANGERING!!**

DANGEROUS SITUATIONS - NOT AN ALL INCLUSIVE LIST:

- **Pointing a firearm up-range (toward spectators), whether loaded or not.**
- **Dropping a firearm, whether loaded or not.**
- **Possessing a loaded firearm when not under the direction of a designated range official.**
- **Allowing the muzzle of the firearm to sweep across any portion of your body whether loaded or not.**
- **Placing your finger on the trigger during the act of drawing from your holster or before the firearm is pointed downrange.**
- **Placing your finger on the trigger while moving through or in a designated non-shooting area.**
- **Using a holster which does not retain the firearm securely or which carries the firearm in a dangerous manner or at a dangerous angle.**
- **Using ammunition which is unsafe for your firearm.**

By signing this document I agree: 1) to assume personal responsibility as described herein, 2) to assume the risk involved, and 3) to waive any rights of action against the California Wheel Burners Revolver Club or any of its members for injuries that may occur in connection with a shooting event. I also acknowledge that I have read and understand the Safety Regulations in the Official Rules of the NRA.
